#### Gentlemen and Ms. McMahon:

We understand that the City of St. Pete Beach has faced unprecedented issues in the last few weeks due to the resignation of four out of five City Commissioners. It is our understanding that the City has already appointed three new City Commissioners, and may appoint a fourth City Commissioner on January 9, 2024.

As you are aware, the continued quasi-judicial public hearing on the Sirata Resort ("Sirata") Conditional Use Application (CUP 23053) is scheduled for the following day, January 10, 2024. Sirata is concerned about the integrity of the proceedings and the applicant's due process rights if the January 10th public hearing moves forward. If a new Commissioner is appointed on January 9th, it is not possible for that Commissioner to have adequate time to review and digest the voluminous amount of reports, documents and materials contained in the record. If a new Commissioner is not appointed, there will only be four sitting Commissioners. The City Commission has routinely granted continuances for applicants in order for the applicant's case to be heard by a fully seated City Commission, and we would request that the same decision be made for Sirata if no one is appointed to the vacant seat at the January 9th meeting. Regardless of the outcome on the January 9th meeting, proceeding with the hearing on January 10th would be extremely prejudicial and would result in a deprivation of the applicant's due process rights.
